Meet with your High School Counselor!			
 Discuss what opportunities may be available to you for dual or concurrent credit and find out if they have any specific dates, deadlines, or procedures you need to follow in addition to Collin College's. Apply at applytexas.org (New Students) 			
 Double check you are applying for the correct term and that you fully submit your application. Please allow 2-3 business days for your application to be processed. Your Workday and OneLogin information will be emailed to your personal email once accepted. Be sure to check your spam folder. 			
Set up OneLogin			
 You'll receive your OneLogin username and temporary password via helpdesk@collin.edu Tip: Set up OneLogin on a device that you will have access to at all times. Click on the Workday app in the OneLogin portal (collin.onelogin.com) Please review your customized list of registration requirements through Workday Tasks TSI (New Students) 			
 □ Take the TSIA2 or provide proof of waiver/exemption □ Minimum score requirements for the TSIA, waivers, and exemptions on page 2 □ Additional information and sign up instructions are available online at: www.collin.edu/studentresources/testing/availabletesting/tsi.html □ Returning students with a partial TSI status will not see a TSI hold, but may need to provide scores if they are signing up for a course in the subject that they do not have scores for on file. ■ Bacterial Meningitis Vaccine (Students taking courses on a Collin Campus) 			
 Students taking courses on a Collin campus will need to provide a valid bacterial meningitis vaccine record or exemption at least 10 days prior to the start their course through Med+Proctor. □ All registration will be done online through Workday □ Go to your "Academics Hub" □ On the left side under "Planning and Registration" click on "Find Course Sections" □ Use the search features to find courses that work for you, you can register for one course at a time or build a saved schedule and register from your saved schedule once you are happy with it.
