Course Title: How to Start and Operate a Child Care Business.

Course Description: Learn the State of Texas requirements & the application process needed to start your own child care business. Some of the many subjects discussed will be: The four different types of family child care facilities. Child care education philosophies and methods of educating children (center based, Reggio, Montessori, Waldorf, Parent Co-ops, High Scope), director and caregivers qualifications, types of ownership, plan of operation/program planning, personnel interviews, supervising personnel, location, advertising, curriculum, tuition/teacher salaries, office management personnel, school tours, and operation of a facility, setting and keeping a budget (the budget fundamentals), State of Texas health and safety practices, record keeping of student & personnel information (immunizations, administering of medication, food allergies, attendance, tuition, etc.), .

- 4. Learn about the needs of staff and proper staff training as required by the State of Texas
- 5. Receive information on Employee Resources and How to Keep Your Employees Motivated
- 6. Discuss curriculum needs and the four major types of licensed childcares as well as the major methods/philosophies of early childhood education. (Montessori, center based, Reggio, Waldorf, High Scope, Parent Co-ops, etc.)
- 7. Advertising methods: Internet, website, free advertising, Facebook, etc.
- 8. Learn the Basics of Budgeting: Income Level vs. Program Costs, how to set and keep a budget
- 9. Staff and Director Requirements
- 10. Record Keeping: Learn about how to find & create the forms necessary for a Child Care facility as required by the state and the electronic resources available to child care facilities. (Record Keeping: Emergency Drills, Immunizations, Criminal History Checks, Attendance, Playground Safety Check List, Emergency contacts, Snack and Meal Requirements, Administration of Medication, Tuition, CPR and First Aid Certifications, etc.)
- 11. Snack and Meal Planning Standards set by the State of Texas Minimum Standards.
- 12. Ideals for Low Cost Start Up
