Personal History Statement Instructions

Students are exposed to confidential and law enforcement sensitive information. A thorough background investigation is required to properly evaluate the suitability of applicants' eligibility for attendance.

These instructions are provided as a guide to assist you in properly completing your Personal History Statement. It is essential that the information is accurate in all respects so please read all instructions carefully before proceeding. The Personal History Statement will be used as a basis for a background investigation that will determine your eligibility for acceptance as a student.

- 1. Your application must be printed legibly in **BLACK INK** by the applicant or typed. Answer all questions truthfully and accurately.
- 2. If a question is not applicable to you, enter **N/A** in the space provided.
- 3. Avoid errors by reading the directions carefully before making any entries on the form. Be sure your information is accurate and in proper sequence before you begin.
- 4. You are responsible for obtaining correct information and documentation. Errors will not be viewed favorably. ALL ADDRESSES MUST BE COMPLETE WITH ZIP CODES.
- 5. If you need additional space for your answers, attach an additional sheet or sheets as needed. Be sure to indicate what question number and page this refers to.
- 6. An accurate and complete form will help expedite your application. Omissions or falsifications will result in disqualification.
- 7. You are responsible for furnishing any changes and/or updating your application as needed, such as address changes or telephone changes in writing.
- 8. Any candidate submitting an incomplete application WILL NOT BE CONSIDERED. application will be evaluated on completeness and neatness.
- 9. The following documents must be submitted with the application (photocopies are acceptable in most cases, providing you bring the original with you.)
 - Recent photograph. (Must be a 2 X 2 passport photo.)
 - Copy of your Social Security card. (Bring original with you.)
 - Copy of your birth certificate. (Bring original with you.)
 - Copy of your valid Texas driver license or a copy of another State's driver license. Applicant must possess a valid Texas driver license prior to completing the course.
 - Copy of your High School diploma or GED certificate. (Bring original with you.)
 - Copy of your DD-214 if applicable. Must possess an honorable discharge. (Bring original with you.)
 - Original certified copy of your Naturalization papers, (if applicable). (Bring original with you.)
 - Copy of current proof of automobile liability insurance. (Bring original with you.)

Before you begin to fill out this personal history statement, please ensure that you meet the following requirements. You must meet <u>all</u> of these requirements to qualify for licensure as a peace officer in Texas.

Initial:	I am a citizen of the United States of America.
	I have earned a high school diploma or a GED.
	I have never been convicted, plead guilty (nolo contendere), nor have I been on court-ordered community service/probation or deferred adjudication for a Class A misdemeanor or a felony.
	During the last ten (10) years, I have not been convicted, plead guilty (nolo contendere), been on community service/probation or deferred adjudication for a Class B misdemeanor in this state, other state, or while serving in the military.
	I have never had a military court martial that resulted in a dishonorable or bad conduct discharge.
	I am not prohibited by state or federal law from operating a motor vehicle.
	I am not prohibited by state or federal law from possessing firearms or ammunition.
	I am 21 years of age, (or 18 years of age if the applicant has received an associate's degree or 60 semester hours of credit from an accredited college or university or has received an honorable discharge from the armed forces of the United States after at least two years of active service.)
